

Our School Construction Program

ur mission at the Digicel Foundation is to work to provide opportunities for all, starting with the children who are the future of Haiti. That's why for 12 years we have been improving the physical environment in which they receive the breadth of their education.

Since 2007, our school construction program has reached many milestones. Last March, we ended our fiscal year with the celebration of our 175th school. And in response to

the growing demand for school construction projects across the country, it was decided to continue working in this sector, which has always been one of our main pillars of intervention.

The goal for the 2018–2019 fiscal year was to inaugurate four new projects. However, the many difficulties encountered, related to the unstable socio-political situation, caused a delay in the execution of this work. Nonetheless, we are pleased to have been able to open

two new schools: Ecole Nationale Congréganiste de Bainet, in the Southeast department, and the expansion of the Centre d'Etudes de Gamaliel in Beraud in the South department. This brings the number of schools built by the Digicel Foundation, in the country's ten departments, to 177.

At the end of this fiscal year, the remaining two schools were in the final phase of construction: Ecole Nationale de Cotton in Jean Rabel in the Northwest and Collège Saint Louis Marie de Montfort in Delmas 31 in the West department.

In addition to a minimum of six classrooms, all these construction projects include an administrative block, a sanitation block, a security fence and, in some instances when possible, a sports court.

In the past year, the Digicel Foundation also engaged in special projects in two of our

existing schools. Collège Andrew Grene, located in Cité Soleil and built in 2011, received a basketball court along with bleachers. The financing of the project was provided by our longtime partner, the Andrew Grene Foundation, and now 249 students attending the school are delighted with their new facilities and are quickly improving their skills on the court. Institution Mixte Rescue One Child, also built in 2011, benefitted from a school improvement project which included the electrification of the school premises mainly to support a new computer lab.

A refresh of the older buildings...

One of our main goals is to provide child-ren, attending the schools built by the Digicel Foundation, a safe environment that facilitates better learning. Thus, every year we improve our construction plans and continually reinforce safety features in the buildings that need it.

Once again this year, we continued with repairs to nine schools, two of which are among the first schools built by the Digicel Foundation

during the 2007-2008 fiscal year and which benefited from structural reinforcement. The other seven schools are buildings located in the South, Nippes, Northwest, and West departments that were affected by Hurricane Matthew.

The Digicel Foundation's contribution to Haiti's educational sector is very significant and we are proud to welcome over 60,000 students to the schools we have built. We are looking forward to very soon reaching a milestone of 180 schools built.

uilt in 2007, the Centre d'Etudes de Gamaliel, located in Beraud in the South department, is part of the first group of schools built through the Digicel Foundation's construction program. At the time, the school quickly became a reference in the community because it was equipped with well ventilated classrooms, an administrative block, a solar-powered computer lab, etc.

Unfortunately, in September 2016 the building was severely damaged by Hurricane Matthew, causing great concern for the future of the school among its community members, who cherished it so much. Confident in the excellent relationship that has always existed between our school and the Digicel Foundation, I quickly reached out. Our cry for help was heard and answered with the spontaneity that has always characterized the Foundation team.

Our expectations were fulfilled beyond our dreams. Indeed, in addition to the repair and reinforcement of the structure in the original building, we were offered a new building with six classrooms. Therefore, the Centre d'Etudes de Gamaliel was completely revitalized and continues to be, as the people in the community so aptly call it, the "benchmark" in edu-

cation in the area; thanks to both the quality of the instruction provided and the beauty of its premises. As such, the school was selected by the Ministry of National Education for the first time as the seat of official examinations. In addition, applications for admission for the new academic year are steadily increasing. Our estimate is that our current student population of 250 will double by next year.

I have no words to express our gratitude to the Digicel Foundation, which gives hope to hundreds of children through its support. Thanks to the Foundation, the Centre d'Etudes de Gamaliel will continue, in much improved conditions, its mission to educate good citizens for the future of Haiti.

During the preliminary phase, training sessions on Community Management, School Development Projects, School Maintenance, and other topics were presented to our team of trainers by specialists from the Ministry of National Education. Upcoming training sessions will address other subjects, such as: Project Development and Management, Pedagogical Supervision, Environmental Protection, First Aid, Conflict Management, etc.

Furthermore, to improve our professional development program new topics are introduced yearly. For example, the Alliance for Disaster Management and Business Continuity (AGERCA) conducted a three-day seminar on risk reduction and disaster management in schools.

Additionally, an innovative creative writing workshop for poetry, slam and story-telling was born out of a partnership with the University of Quebec at Montreal (UQAM)'s School of Educational Sciences. This project which aims to strengthen students' reading and writing skills, while allowing them to freely express their emotions, was a great success with the students from participating schools and the general public.

In order to help communities prepare for and cope with current emergencies and crises, we had the opportunity to welcome Dr. Kathryn Adams, Ph.D, for a training session on the consequences of trauma on learning, as well as adequate responses in crisis situations: living in and beyond the situation of violence, education for recovery and resilience.

Our Grants Program

ver the past years quite a few non-profit, community-based, organizations have emerged and are providing solutions to many of the issues facing the country. Two years ago, in celebration of its 10th anniversary, the Digicel Foundation launched its "Konbit pou Chanjman" (Come Together for Change) campaign, through which local organizations were invited to submit proposals for projects covering areas such as education, culture, inclusion, livelihoods, access, disaster prevention, etc.

We were very excited by the variety of proposals submitted and some, in particular, retained our attention. The reforestation project by EJTA in the South-East department, which planted 13,000 fruit trees, or that of PAVODEV, in the Nippes department, whose distribution of fertilizers to 300 farmers in the town of Paillant has provided a significant boost to their production capacity. On the other hand, other projects have focused on empowering people. In the West department, an organization called HAGN focused on empowering 300 young girls in Solino, by offering them a meeting place to better inform themselves and avoid teen pregnancies. In the city of Les Cayes, in the South department, AJPE has conducted training sessions for the youth to raise awareness about issues related to gender-based violence.

The first edition of "Konbit pou Chanjman" was a success both in terms of the number of applications received and the quality of the projects proposed. It was a real celebration of the work of these community leaders who inspired us with their commitment and continue to motivate us to keep our pledge to work for a better tomorrow for our country. Initially the campaign was to be held only once to mark this important milestone achieved by the Foundation; however, thanks to its resounding success, the decision was made to continue

and improve the initiative, which has now become an annual event.

The second edition of the program was launched in May 2018, and in comparison to the first some important details are worth highlighting

- We recorded a 50% increase in the number of applications received over the previous year, for a total of 452 submitted proposals.
- -The number of winners increased from 11 last year to 16 this year, with at least one winning organization per department. The plan was to sponsor 15 winning organizations, however a 16th was added as an exception, following

the serious water crisis in the community of Grand-Bois Cornillon. The organization "Union des Jeunes Progressistes pour l'Avancement de Grand-Bois Cornillon" (Union of Progressive Youth for the Advancement of Grand-Bois Cornillon) was among the 25 finalists, and had submitted a proposal for improving access to water in the district. Touched by the alarming situation, the jury decided to help and speed up the process for this organization by financing its project. A memorandum of understanding was signed even before the award ceremony was held for the second edition of "Konbit pou Chanjman".

- The prize per winning organization was increased from 700,000 to 800,000 Gourdes, for a total amount of approximately 13 million gourdes. Due to the socio-political unrest in the country, the final awards ceremony could not be held during the last fiscal year which ended on March 31st; instead, it was held during the 2019-2020 fiscal year, on April 4, 2019. However, funding for the second edition of Konbit

pou Chanjman was included in our 2018-2019 budget and appears in our audit report this year.

We look forward to visiting the 16 winning organizations to see first-hand the progress being made in their communities through their development projects.

Long-term Partnerships....

The Digicel Foundation is well aware of the enormous work done by Non-Profit Organizations in the country, and considering the financial hurdles they often face, it has supported hundreds of them over the past 12 years. Our partnerships with some of these organizations have lasted for multiple years. In this report, we are highlighting the work of two of our long-term partner organizations, namely, HELPR and Special Olympics Haiti.

Through its scholarship program for outstanding students in a precarious economic situation, HELPR offers invaluable support to dozens of young Haitians. With funding of \$ 10,000 USD

from the Digicel Foundation, HELPR was able to cover the cost of qualified tutors to supervise the dissertation work of graduating students in the program. Knowing that about 50% of graduating students in the Haitian university system fail to submit their thesis, there is no doubt that this grant has been very useful.

As a partner to Special Olympics Haiti since 2007, the Foundation's funding for this year was dedicated to training and conditioning athletes for participation in the 2019 World Games, which took place in March 2019 in Abu Dhabi, United Arab Emirates. The Digicel Foundation donated \$ 50,000 USD, which helped better prepare athletes for the games by refining their training in the sports disciplines in which they competed. Thus, training was in-



tensified with reinforced technical supervision in unified soccer, track and field, and equestrianism.

As has always been the case with their participation in international competitions, the athletes brought joy to the whole country by achieving extraordinary results. The Haitian delegation came home with a total of 10 medals, 3 gold, 6 silver and 1 bronze. It was an incredible experience for the athletes. Below some of their testimonials:

"I'm happy to have my medal around my neck. Some of the kids in my school had told me that I had no value, that I shouldn't have been chosen to participate in these games, and that I would be a burden for the team. So this gold medal will prove to them that I was capable. " -Joseph Stivenson, unified soccer team member, gold medalist.

"I thank God for allowing us to obtain this victory. I have been waiting for this medal since 2015. Finally, my dream came true and I hope that in future games, I will get many more." - Yves Christopher Banks, unified soccer team member, gold medalist.

The Digicel Foundation was the first organization to take an interest in this village, and for that we will be eternally grateful to their dynamic team.

he peculiarity of an initiative like the Digicel Foundation's "Konbit pou Chanjman" is that it allows local organizations to provide solutions to major problems facing their communities, that in this day and age should no longer exist. Unfortunately in Laguamithe, located in Mombin Crochu in the Northeast department, the population lacked even the most basic sanitary facilities, such as latrines.

This very alarming situation worried us be-

cause residents were contracting all kinds of diseases and epidemics. The need to find a solution was imperative. It became more dramatic when a mother of just one month found herself trapped in a latrine collapsed, because of its extremely poor condition. This woman was saved thanks to the intervention of local residents.

Coincidentally, we were made aware of the "Konbit pou Chanjman" campaign scheduled by the Digicel Foundation. We quickly organized a meeting of Fraternité Laguamithe, our association, and submitted our project to build 15 latrines for the community. We were delighted to hear that our project was one of the winners of the first edition, allowing us to benefit from a grant of 700,000 gourdes, from the Digicel Foundation, for the implementation of our project.

Now more than 400 community residents

benefit from these sanitary facilities, and we feel a great satisfaction when we note that the number of people affected by the epidemics has drastically decreased. This is an example that has made us realize that together we can accomplish great things. A committee has been set up to guarantee the maintenance and the cleanliness of the premises.

The Digicel Foundation was the first organization to take an interest in this village, and for that we will be eternally grateful to their dynamic team. On behalf of all the beneficiaries of this project, a very big thank you to the Digicel Foundation for always being attentive to the needs of the Haitian population.



Digicel Haiti Foundation Notes to Financial Statements

1) ORGANIZATION

"Fondation Digicel Haiti" (Digicel Haiti Foundation: the Foundation) is a private, non-profit organization founded by Mr. Denis O'Brien. The official authorization and by-laws of the Foundation were registered at the Mayor's office in Pétionville on February 27, 2007 and published in Le Moniteur on April 3, 2008. The objectives of the Foundation are to promote community programs in Haiti that embrace and reflect the educational, social and cultural aspirations of the community. The majority of projects funded address community needs, encourages volunteerism and civic engagement, promote leadership with integrity, promote opportunities for marginalized groups, and include tangible products such as school buildings.

Although the Foundation has a vast range of objectives, it has a special focus on two areas: education and sustainability. The focus on education arises from a fundamental need across the country to increase access to quality education. Sustainability of each project funded is the utmost importance to the Foundation prior to taking on new projects as they seek to assist communities towards self-sufficency as opposed to dependence on continued assistance.

To achieve these objectives, the Foundation, through direct cash and non-cash contributions, works alongside and through structured community organizations to ensure the smooth implementation of projects. The Foundation works with Governmental and non-Governmental Organizations throughout Haiti. The funds disbursed by the Foundation are grants that the receiving organizations will not be required to repay; however, the beneficiaries are required to keep and present accurate records on how all funds are utilized.

The operations of the Foundation are funded primarily by contributions from Unigestion Holding S.A. (Digicel Haiti), a related party.

The registered office of the Foundation is located at Unigestion Holding S.A. (Digicel Haiti) in Turgeau, Haiti.

2) BASIS FOR FINANCIAL STATEMENTS PREPARATION

(a) Accounting framework

The financial statements are prepared in conformity with International Financial Reporting Standards (IFRS).

These financial statements were approved by the CEO on June 19, 2019.

Digicel Haiti Foundation Notes to financial statements

2) BASIS FOR FINANCIAL STATEMENTS PREPARATION (CONTINUED)

(b) Basis of measurement

These financial statements are presented on a historical cost basis, using the accrual basis of accounting.

The fair value of the financial assets and liabilities is practically equal to their cost.

(c) Currency presentation

The functional currency of the Foundation is the Haitian Gourde but at the request of Management, the financial statements are presented in US Dollars.

(d) Use of estimates and judgment

In preparing these financial statements, Management must make estimates and assumptions that affect the application of accounting policies and the reported amounts of assets and liabilities, and the presentation of contingent assets and liabilities, and the income and expenses of the year. Estimates and underlying assumptions are reviewed continuously. Revisions to accounting estimates are recognized in the period in which the estimates are revised and in future periods affected. Although these estimates are based on Management's best knowledge of current events and actions, actual results may differ from those estimates.

The most significant financial statements accounts affected by estimates and assumptions are:

Note 6 Accounts receivable - impairment provision

Note 8 Fixed assets – depreciation.

Balance Sheet Construction materials - valuation and obsolescence

According to Management, the financial statements were prepared on an adequate basis using fair judgment in all material respects and in accordance with the accounting policies summarized below.

3) SIGNIFICANT ACCOUNTING POLICIES

The accounting policies set out below have been applied consistently to all periods presented in these financial statements.

(a) Conversion of foreign currencies

Transactions denominated in currencies other than the functional currency (Gourde) are recorded in the functional currency at the actual exchange rates existing at the dates of the transactions.

Monetary assets and liabilities denominated in currencies other than the functional currency are reported at the exchange rates prevailing at year-end. Any unrealized gain or loss arising from a change in exchange rates subsequent to the date of the transaction is included as foreign exchange gain or loss in the statement of income and expenses.

The presentation currency is the US dollar. In accordance with IAS 21, the results and financial position of the Foundation expressed in the functional currency are translated into the presentation currency as follows:

- Assets and liabilities for each balance sheet presented, are translated at the closing rate at the date of each balance sheet;
- Net assets other than income for the year are translated at year-end exchange rates;
- Income and expenses for each income statement are translated at average exchange rates.

All resulting exchange differences are recognized as a "currency translation adjustment" eparate component of net assets, as translation adjustment.

(b) Cash and cash equivalents

Cash and cash equivalents are cash on hand and current bank accounts which are readily convertible into cash without notice. These are reflected at cost.

3) SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

(c) Construction materials

Contruction materials are recorded at cost and represent a reserve of metal perfiles, a frequently used material, difficult to find in Haiti, and paint. They are sold to contractors as needed.

(d) Contributions

Contributions to the Foundation represent cash and non-cash donations. Income from these donations is recognized when the conditions related to the transfer of assets from the contributor to the Foundation are met.

Cash contributions from Unigestion Holding S.A. (Digicel Haiti) represent contributions received or receivable in cash from that company in Haiti.

Other cash contributions are provided by several international donors.

Contributions received for charges to be recorded in future years are deferred until the year where the related charges are incurred.

Non-cash contributions are recorded as income when received, at their estimated fair market value by the Foundation.

(e) Funding of projects and advances to contractors

A contractual framework surrounds each construction / renovation of school project. Per the terms of the contract, specific phases of work are identified and give rise to payments to the contractors.

Payments made are recorded as advances to contractors on projects. During the year, as projects are completed, the related liability is set up with a corresponding charge to the funding of projects expenses; and, later on, the advances are eliminated against the liability.

Expenses for grants are expensed when the disbursements are approved with the exception of grants made for the construction of schools that are treated as described above.

(f) Income taxes

Due to its legal status, Digicel Haiti Foundation is exempt from income taxes.

4) FINANCIAL RISK MANAGEMENT

Liquidity risk

Digicel Haiti provides most of the liquidity of the Foundation. The Foundation evaluates its ability to meet its obligations on an ongoing basis. Based on these evaluations, the Foundation devises strategies to manage liquidity risk.

Credit risk

Cash and cash equivalents are kept at a large local bank. Management does not believe there is a risk of non-performance by that bank.

Accounts receivable are closely monitored and impairment provision is created whenever necessary. The net amount receivable is considered to be a low credit risk.

Advances to contractors for projects and to suppliers are with reputable contractors and Management believes there is no significant impairment risk thereon. If required, an impairment provision is recognized.

Foreign exchange risk

Foreign exchange risk results from inappropriate matching between the assets and liabilities denominated in foreign currency, which could lead to a long or short position impacted by the fluctuation of the Haitian gourde versus those foreign currencies.

At March 31, 2019 and 2018, the Foundation respectively maintain short position in US dollars of \$ 4,054 and \$ 98,802. For each variation of one gourde versus the US dollar, the position in US dollars would result in an exchange gain or loss of approximately \$ 50 in 2019 and \$ 1,500 in 2018.

4) FINANCIAL RISK MANAGEMENT (CONTINUED)

Operational risk

Management has put in place procedures to ensure that all constructions/renovation of schools are in line with the estimates and that all disbursements are properly authorized and well documented.

Qualified engineers, working at Digicel Haiti Fondation, regularly inspect the construction sites to ensure that the construction plans are followed, and not only in terms of the quality of the materials used but also in terms of the competence of the workers and of meeting the deadlines.

Also, proformas are obtained whenever possible and all checks need two signatures from top Management, when the payment is \$ 100,000 or more. Between \$ 100,000 and \$ 50,000, the CEO or the Finance Manager may sign with a member of top Management. Under \$ 50,000, the CEO may sign with the Finance Manager. Finally, adequate segregation of duties combined with restricted access to the accounting system contributes to minimizing operational risk. The accounting system is also designed to produce reports on a timely basis.

- (a) In 2019 and 2018 respectively, 2 and 3 school construction projects were completed and furnished; in 2019, it was in the departments of South-East and South. In 2018, repairs were completed in 9 and 15 schools, most of which were located in departments affected by Hurricane Matthew. In addition, in 2019, a multipurpose structure was built at College Andrew Grene in the West.
- (b) Training expenses include the remuneration of trainers and related expenses such as per diem, travel and lodging expenses. Furthermore, these expenses also cover training held during the summer at Camp Perin for directors and teachers working in the schools built by the Digicel Foundation.

13) KONBIT POU CHANJMAN

In March 2017, Digicel Haiti Foundation launched a grants competition in honor of its 10th anniversary celebration. The initiative, entitled Konbit Pou Chanjman, sought to award 10 local organizations with US\$ 10,000 each to implement a community project in one of the country's 10 departments. Organizations desirous to implement a project were invited to apply for a grant in the following areas: education, culture, inclusion, access, livelihoods, and disaster prevention. More than 300 applications were received, demonstrating not only a great interest in the campaign, but also a great need for small grants across the country. The grants were disbursed totally during the year 2019 and are reflected in **note 11 c.** Thus, the Board of Digicel Haiti Foundation's decided to launch a second edition of the Konbit Pou Chanjman campaign in May 2018.

The second edition sought to award 15 local organizations with G 700,000 each to implement a community project in one of the country's 10 departments. The number of applications increased to more than 450, of which 72 projects were selected for the second round which entailed field visits made by members of the Digicel Haiti Foundation staff and Board. 25 of the organizations visited were selected as finalists and were invited to Port-au-Prince in February 2019 for governance training and to present to the campaign jury. The grand finale scheduled for March 2019 had to be delayed to April due to social and political unrest experienced in early 2019.
